Terms and conditions:

In accordance with South African legislation on distance selling any claim for a refund must be made within 30 days of the first module being dispatched. Thereafter no refunds will be given.

On the rare occasions that a student's circumstances change dramatically and a student cannot continue their studies, Pet Sense College, at its sole discretion, may reward a refund, after 30 days, subject to the following conditions:

1. Registration fees paid in respect of Pet Sense College, and other awarding bodies are not refundable.

2. No module notes or books are returnable.
3. Any module notes provided will be charged at a rate appropriate to the price band for the course, prices available on request.
4. Any module that has had work submitted for marking will be deemed to have been completed (even if returned for re-submission) and charged at the full rate.
5. Any bank charges related to payments received or collected will be deducted from any refund awarded. The right is reserved to levy an administration charge in all cases.
6. Any student wishing to change course will be able to transfer any funds paid (subject to conditions 2-6) at any stage within 6 months of the despatch of their first module. They will be required to re-register.
7. All recordings, webinars and course material is subject to international Copyright laws and may not be distributed by students. All material is solely for this use of the registered student.
8. Should payment not be received on time, the student will be suspended until such time that full payment is made for the course.
9. Students are to attend 90% of the classes and have 1 week extensions on assignments and project deadlines when necessary.
10. WhatsApp groups are used for coordination purposes. Any questions related to the course should be emailed directly to the facilitator for assistance.

It should be emphasised that claims for refunds are **very** rare (less than 1 in 300 registrations at the last count) and these are usually due to the student's circumstances changing dramatically as would be the case in serious long term ill health. Before asking for a refund after the 30 day period students are reminded that they have bought a product which, like any other product, cannot be returned for a refund after 30 days simply because you have decided that it no longer suits your requirements.
